Agreement for Employment Medical Services

The agreement will be made between **member company and Elite Corporate Wellness** a professional medical corporation which operates UnitedAg Health and Wellness Centers.

Scope of Services

• Elite shall perform **specialized immunization and medical screening services** that are usual and customary for medical employment physical screening and employment medical monitoring.

Compensation

• Member company shall pay Elite Corporate Wellness the fees calculated in accordance with the rates of billing for fees identified. **Fees are due 30 days of invoice receipt** upon project completion.

Terms

• The agreement will be effective as of the date of execution by member company and remain in effect thereafter. Either Party may terminate the Agreement by providing at least 60 days in advance with written notice to the other Party specifying the effective date of such termination.



California Vaccine Deployment Timeline



Health care workers, residents at skilled nursing facilities, workers and residents at other congregate living facilities and individuals 65+. Education workers, childcare, emergency services, **food and agriculture.** Transportation, logistics, industrial, residential and commercial sectors, sheltering facilities and congregate settings with outbreak risk. Anyone 50 to 64 years old, people 16-64 years of age and have an underlying health condition, disability or at risk of exposure at work.

County Distribution Process

Each region is responsible for the development and deployment of the COVID-19 Vaccine. Each county in California has developed a timeline specific to their population.



The health departments for Colusa, Monterey, Santa Barbara, Stanislaus and Tulare County will determine the timeline for UnitedAg Health & Wellness Centers.



UnitedAg COVID-19 Vaccine Timeline



Begin vaccinating persons 65 years of age and older. Based on available supply. Individuals 75 years or older will be prioritized due to increased risk of mortality and other severe disease. Vaccinate individuals who work in sectors with high occupational exposure as listed in Phase 1B Tier 1.

Providers may offer doses promptly to people in lower priority groups when demand subsides in the current groups, or doses are about to expire according to labeling instructions.

Documentation of Vaccine Administration

Frequently Asked Questions



Q: Who can receive the vaccine during phase 1a?

A: Members who meet the 65+ criteria and reside near a UA Health & Wellness Center.

Q: Who can receive the vaccine during phase 1b?

A: Ag workers over the age of 18 who are currently enrolled in the UABT health plan and meet the criteria outlined by the California Department of Public Health.

Q: Will any out-of-pocket expense be incurred for members receiving the Vaccine at a UA wellness center?

A: UABT plan participants who receive the vaccine at a UA wellness center will not incur any out-of-pocket cost.

Q: Will dependents be able to receive the vaccine at a UA wellness center?

A: Dependents that do not meet the criteria for phase 1a, 1b and 1c will be able to receive the vaccine according to the California Vaccine timeline.

Q: If I'm an Ag employer/employee who does not have access to a UA wellness center, what are my options?

A: We are working on other options for members who don't have access to a UA wellness center.
